EMERGENCY OVERVIEW

SECTION 5: Firefighting Measures

Suitable fire extinguishing media:

Specific hazards arising from the chemical:

Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. SECTION 6: Accidental Release Measures

Transfer contaminated absorbent, soil and other materials to containers for disposal.
