# Section 4. First aid measures

### **Description of necessary first aid measures**

**Eye contact**

Inhalation

Remove person to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ### Methods and materials for containment and cleaning up

## Small spill

#### Precautions for safe handling

#### **Protective measures**

### **Appropriate engineering** controls

#### **Disposal methods**
